We propose to plug this well back and produce out of the Seven Rivers formation. We propose to set bridge plug @ 1860' and dump 3 sax cement-set another bridge plug @ 1470' and dump 3 sax cement, load hole and run cement bond log; shoot 5 1/2" casing off at approximately 1400' and pull, then run 4 1/2" production string and cement w/approximately 150 sax cement, if does not circulate cement will fill w/ready mix to surface. Current Artesia Pool perfs 1500-12'; 1894-1902'; 1932-44'.
