On test of 4/22/70 this well produced 80 BOPD, no water, with a GOR of 1805/1 (144 MCF) from existing perforations 6024-6044'. We propose to add perfs from 6044-6050' w/2 JSPF and treat all perfs w/1500 gallons of 15% HCl acid and diverting agent. Swab well in and return to production.
