Spud 11" hole 1-11-60. On 1-13-60 8-5/8" OD 22.7# Arisco casing was run and set at 996' with 525 sz. cement circulated. After WOC 24 hours tested casing with 450 psi for 30 minutes with no loss in pressure. Redused hole to 7-7/8" and resumed drilling operations.
