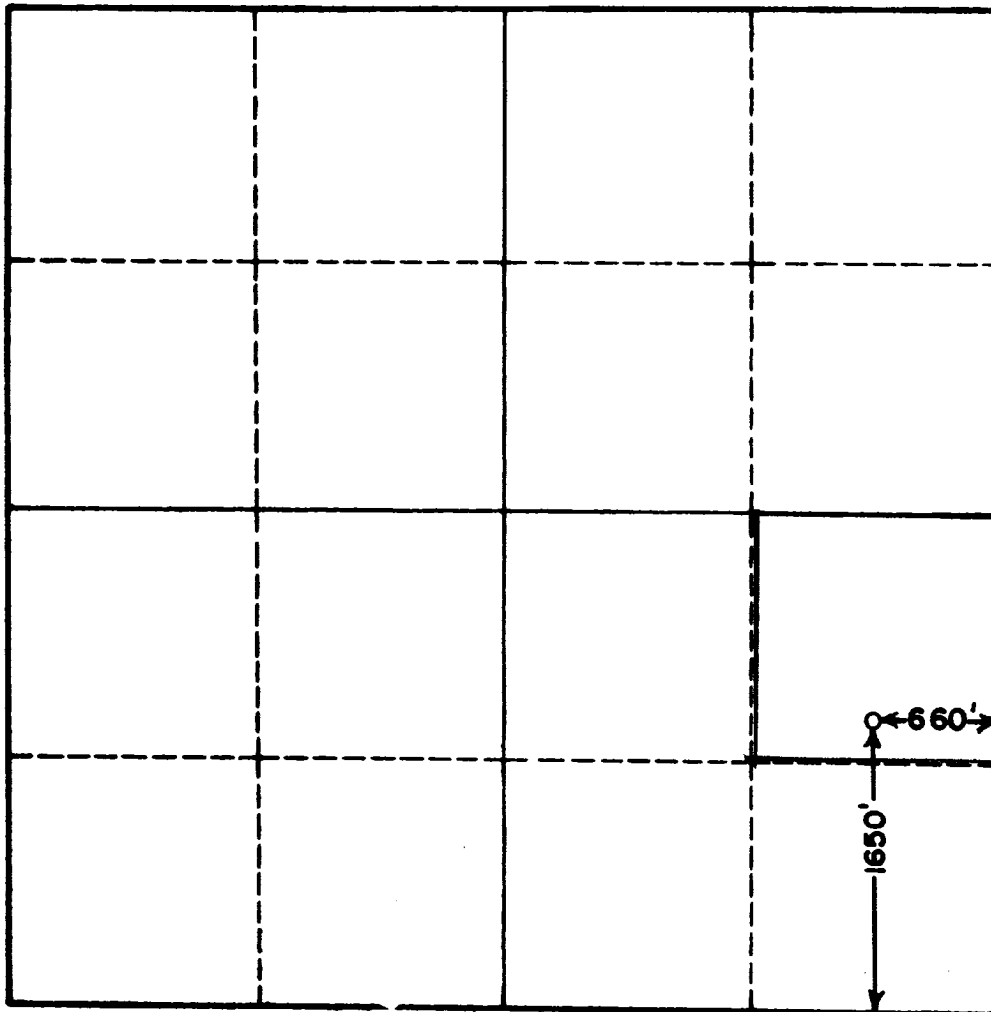

Gentlemen:

On March 10, 1960, a survey was made to locate your State BP Well No. 1 at a point 1650 feet from the south line, and 1960.99 feet from the east line, and your State BO No. 2 1650 feet from the south line, and 660.00 feet from the east line, both in Section 32, Township 17 South, Range 28 East, N.M.P.M., Eddy County, New Mexico.

Beginning at a point marked by a 2 inch iron pipe with a brass plate inscribed as the common corner of Sections 32, and 33, township 17 South, Range 28 East; thence chaining $N0^{\circ} 45'W$ along the east boundary line of Section 32, a distance of 1650 feet to a point marked by a 2 inch wooden hub driven into the ground; from which the east $\frac{1}{2}$ corner of said Section 32, bears $N0^{\circ} 45'W$, 947.76 feet; thence chaining $S88^{\circ} 55'W$, at a distance of 660 feet to the point of location of your State BO No. 2; thence chaining $S88^{\circ} 55'W$, a distance of 1300.99 feet to the point of location of your State BP No. 1; thence chaining $S0^{\circ} 45'E$, a distance of 1650 feet to a point; Thence chaining $N88^{\circ} 55'E$, along the south boundary line of said Section 32, a distance of 1960.99 feet to the point of beginning, closing the survey with an error of 0.38 feet.
