Spud 11" hole 4-24-60. On 4-27-60 8 5/8" OD 22.7# SJ Armo casing was run and set at 1298' with 550 Sx. cement circulated. After WOC 24 hours tested casing with 500 PSI for 30 minutes with no loss in pressure. Reduced hole to 7 7/8" at 1298' and resumed drilling operations.
