Spud 11" hole 2:00 P.M. 6-21-60. On 6-22-60, 8-5/8" 22.7# SJ Armo Casing was run and set at 773' with 500 sacks cement and was circulated. After WOC 24 hours, casing was tested at 400# psi for 30 minutes with no loss in pressure. Reduced hole to 7-7/8" at 773' and resumed drilling operations.
