On 6-29-60 spudded 11" hole. On 7-1-60 8 5/8" OD 22.7# SJ Armaco Casing was run and at 887' with 450 SX cement. Cement circulated. After WOC 24 hours tested casing with 600 PSI for 30 minutes with no loss in pressure. Reduced hole to 7 7/8" at 887 and resumed drilling operations.
