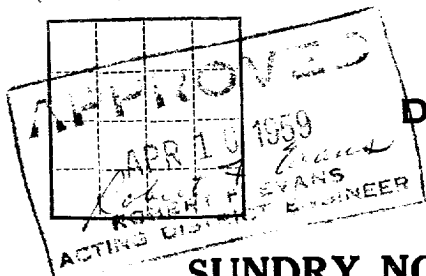

DETAILS OF WORK

On March 31, 1959, we ran 2081' (66 Joints) of 7" OD 8rd thrd 23# used JS casing to 2084' and cemented with 150 sacks neat cement.

After allowing to stand cemented for 72 hours, we tested casing with 2500 psig. cold water pressure. We then drilled plug, bailed hole down and re-ran bailer.

As shut-off proved complete drilling operations were resumed.

Cementing and pressure testing were done by Denton Oil Well Cementing Co.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
