WE PROPOSE TO DRILL THIS WELL AS FOLLOWS:

OBJECTIVE: Pearse Sand (Queen)TOTAL DEPTH: 2150'METHOD OF DRILLING: Cable tools to total depth.CASING PROGRAM: Will run approximately 400' of 10 3/4" OD casing and obtain formation shut-off. If surface water is encountered in sufficient quantities will cement 10 3/4" with 50 sacks. If water is encountered in the Red Sand section of Queen formation will run approximately 1980' of 8 5/8" OD casing and mud with Aquagel and crude oil. If commercial production is indicated a production string of 7" OD casing will be run and cemented immediately above the pay horizon.DRILLING CONTRACTOR: Needham Drilling Company.DRILLING OPERATIONS TO COMMENCE: On or about June 24, 1959.

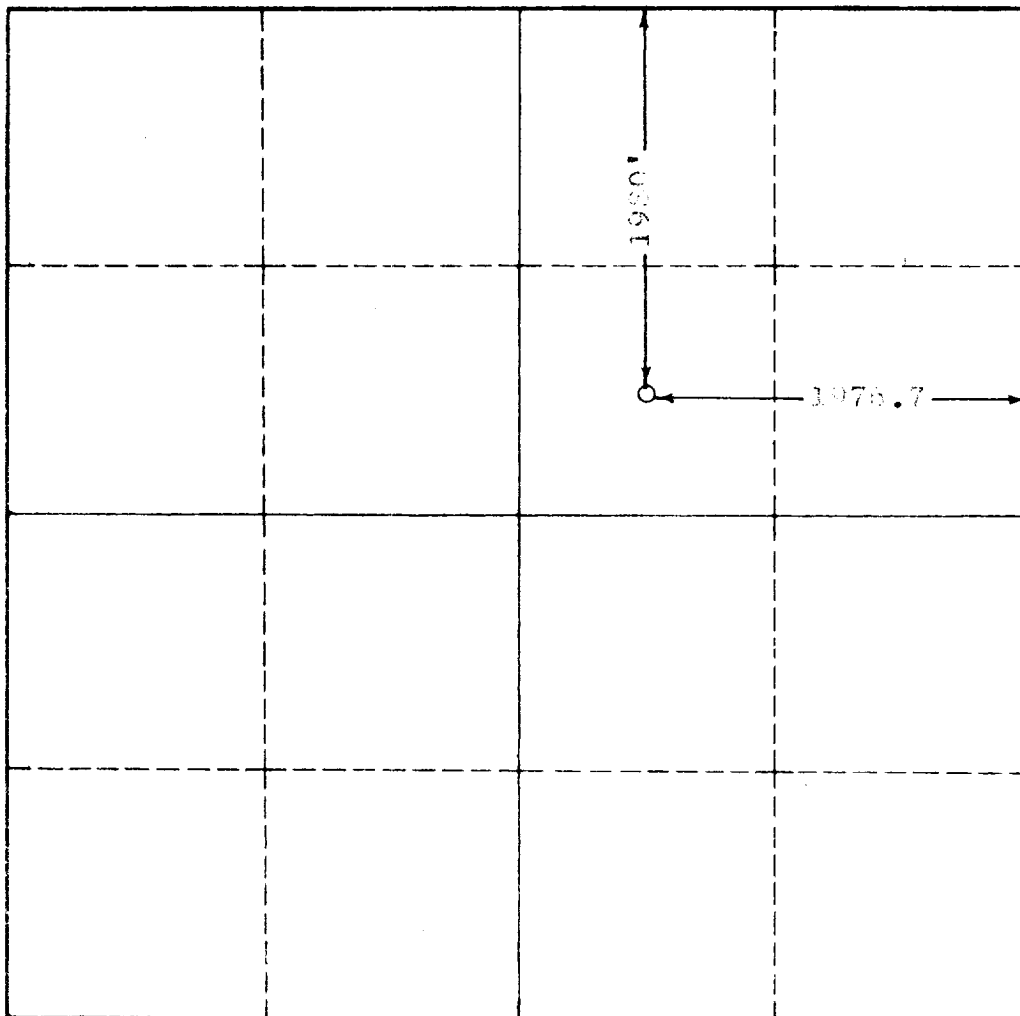
