DETAILS OF WORK

WE PROPOSE TO DRILL THE ABOVE WELL AS FOLLOWS:

OBJECTIVE: Panorama Sand (Queen)

TOTAL DEPTH: Approximately 2140'.

METHOD OF DRILLING: Cable tools to total depth.

CASING PROGRAM: Will run approximately 400' of 10 1/4" OD casing and obtain formation shut-off. Will run approximately 1930' of 8 5/8" OD casing and run with Aquagel and crude oil. If commercial production is indicated a production string of 7" OD casing will be run and cemented with 150 sacks. After fracturing, the 10 1/4" OD casing will be pulled and 50 sacks cement will be spotted above the top of the Salt section.

DRILLING CONTRACTOR: Needham Drilling Company.

DRILLING OPERATIONS TO COMMENCE: On or about October 20, 1959.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.




