DETAILS OF WORK

WE PROPOSE TO DRILL THE ABOVE WELL AS FOLLOWS:

OBJECTIVE: Penrose sand (Queen)

TOTAL DEPTH: Approximately 2080'

METHOD OF DRILLING: Cable tools to total depth.

CASING PROGRAM: Will run approximately 400' of 10 3/4" OD casing and obtain formation shut-off. Will run approximately 1860' of 8 5/8" OD Casing and mud with Aquagel. If commercial production is indicated a production string of 7" OD casing will be run and cemented with 150 sacks. After fracturing well the 10 3/4" OD casing will be pulled and 50 sacks cement spotted above the top of salt section.

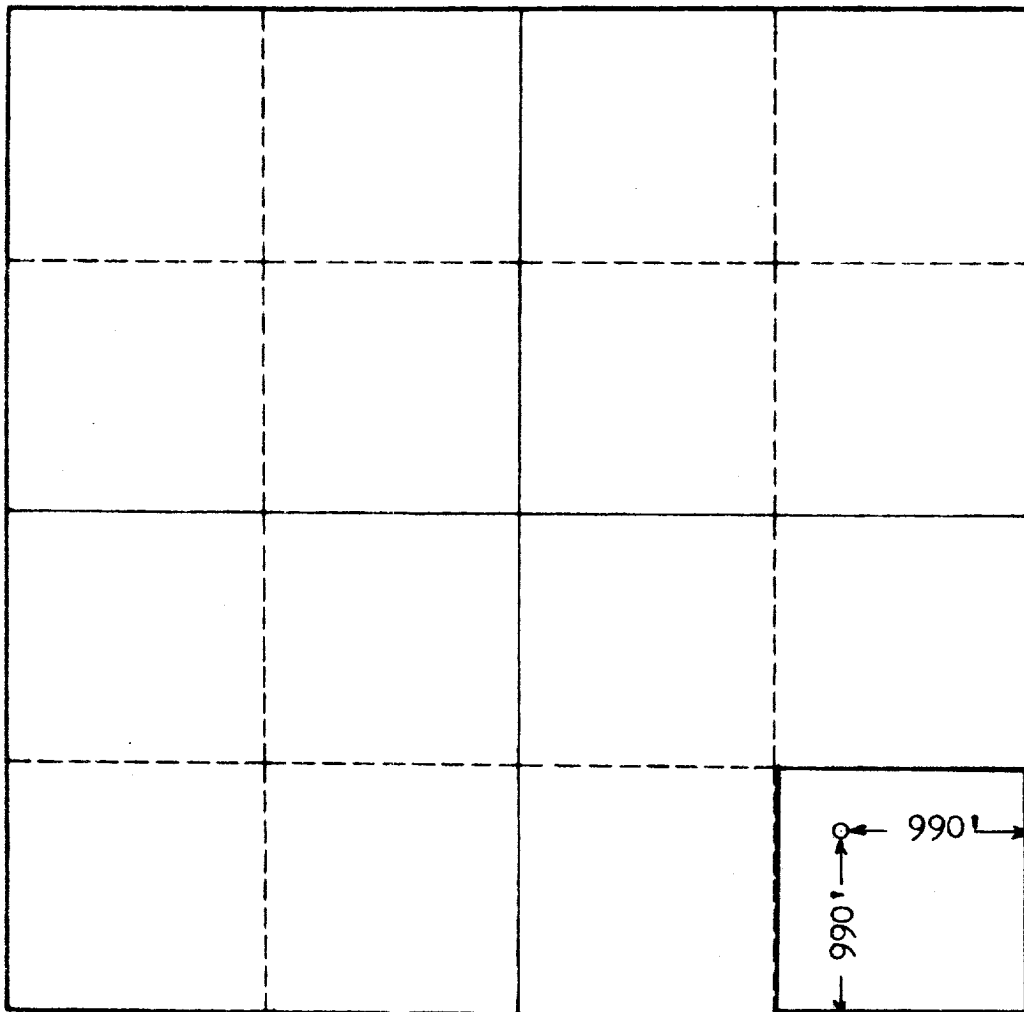
