DETAILS OF WORK

On December 2, 1958, we ran 2751' of 7" OD Std third 230 mixed new & used JS casing to 2754 and cemented with 150 sacks.

After allowing to stand cemented for 72 hours, we drilled plug, bailed hole down and re-ran bailer. As shut-off proved complete operations were resumed.

Cementing was done by Denton Oil Well Cementing Company.
