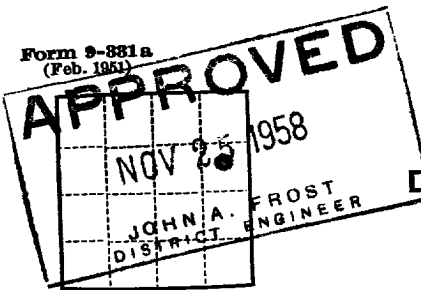

DETAILS OF WORK

WE PROPOSE TO DRILL THIS WELL AS FOLLOWS:

OBJECTIVE: Penrose Sand (Queen).

TOTAL DEPTH: Approximately 2085'.

METHOD OF DRILLING: Cable tools to Total Depth.

CASING PROGRAM: Will run approximately 400' of 10 3/4" OD casing and obtain formation shut-off. If surface water is encountered in sufficient quantities, will cement 10 3/4" with 50 sacks. If water is encountered on the Red Sand Section of the Queen formation, will run approximately 1860' of 8 5/8" OD casing and mud with Aquagel & crude oil. If commercial production is indicated a production string of 7" OD casing will be run and cemented immediately above the indicated pay horizon.

DRILLING CONTRACTOR: Needham Drilling Co.

DRILLING OPERATIONS TO COMMENCE: On or about December 1, 1958.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

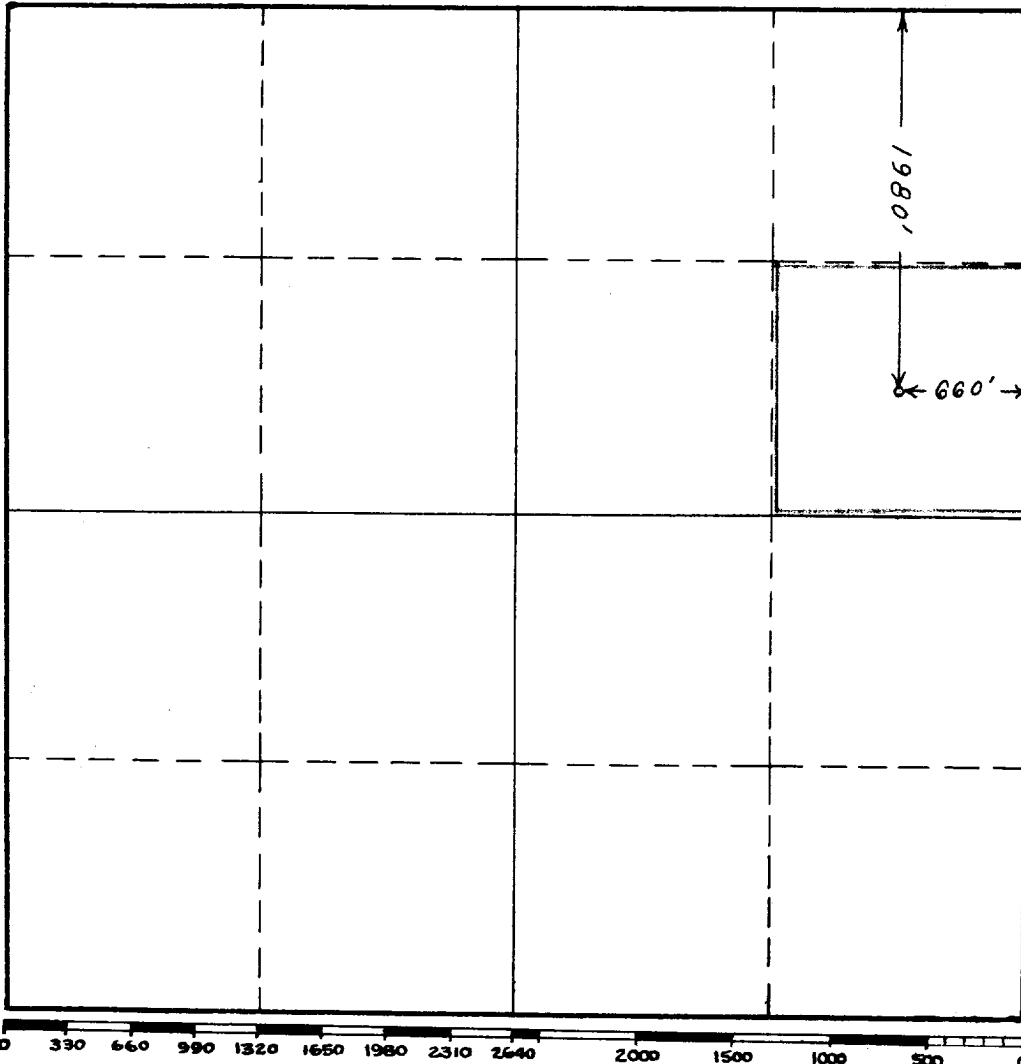
