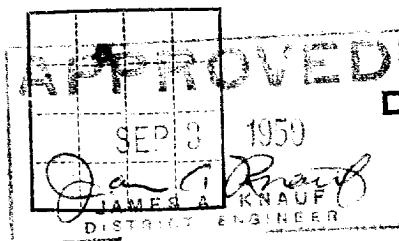

## DETAILS OF WORK

WE PROPOSE TO DRILL THE ABOVE WELL AS FOLLOWS:

OBJECTIVE: Penrose Sand (Queen)TOTAL DEPTH: Approximately 260'.METHOD OF DRILLING: Cable tools to total depth.CASING PROGRAM: Will run approximately 400' of 10 3/4" OD casing and obtain formation shut-off. If surface water is encountered in sufficient quantities, will cement 10 3/4" with 50 sacks. If water is encountered in the Red Sand section of Queen formation will run approximately 180' of 8 5/8" OD casing and mud with Aquagel and crude oil. If commercial production is indicated a production string of 7" OD casing will be run and cemented immediately above the pay horizon.DRILLING CONTRACTOR: Hoodham Drilling Company.DRILLING OPERATIONS TO COMMENCE: On or about September 4, 1959.

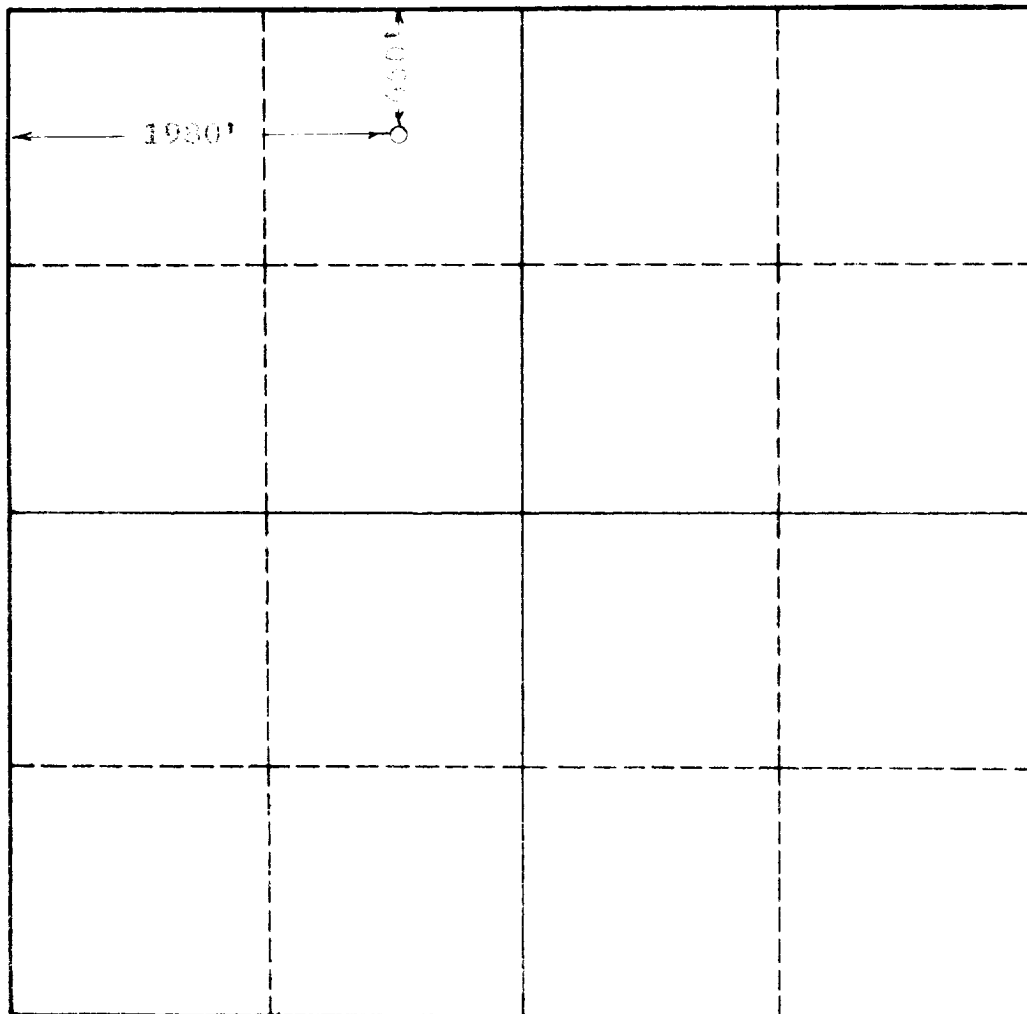
