WE PROPOSE TO DRILL THE ABOVE WELL AS FOLLOWS:

OBJECTIVE: Penrose Sand (Queen)TOTAL DEPTH: Approximately 2050'.METHOD OF DRILLING: Cable tools to total depth.CASING PROGRAM: Will run approximately 400' of 10 3/4" OD casing and obtain formation shut-off. Will run approximately 1850' of 8 5/8" OD casing and mud with Aquagel and crude oil. If commercial production is indicated a production string of 7" OD casing will be run and cemented with 150 sacks. After fracturing, the 10 3/4" OD casing will be pulled and 50 sacks cement will be spotted above the top of Salt section.DRILLING CONTRACTOR: Needham Drilling Company.DRILLING OPERATIONS TO COMMENCE: On or about October 15, 1959.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.



