WE PROPOSE TO DRILL THIS WELL AS FOLLOWS:

OBJECTIVE: Premier Sand (Basal-Grayburg)

TOTAL DEPTH: Approximately 2650'.

METHOD OF DRILLING: Cable tools to total depth.

CASING PROGRAM: Will set approximately 500' of 8 5/8" OD Casing in top of salt and cement with 50 sacks cement. If sufficient water is encountered in the Queen Formation, will set approximately 1975' of 7" OD Casing and obtain formation shut-off. If commercial production is indicated, a production string of 5 1/2" OD Casing will be run and cemented at approximately 2620'.

DRILLING CONTRACTOR: Needham Drilling Co.

DRILLING OPERATIONS TO COMMENCE: on or about April 20, 1958.

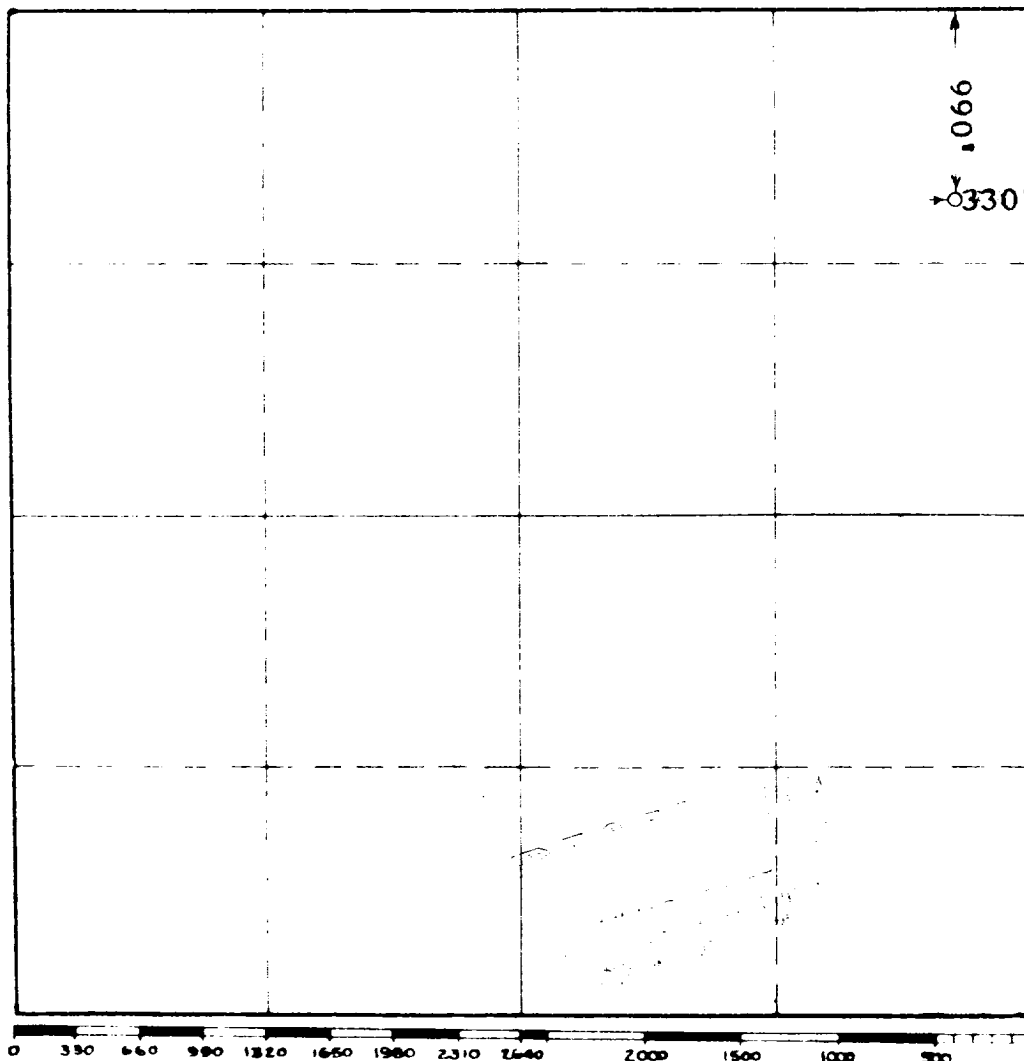
