Perforated 2-7/8" casing from 2962-2966, 2968-2972 w/2 jet shots per ft. Swabbed dry. Fraced perforations from 2962-2966, 2968-2972 w/10,000 gals Humble Frac and 20,000# sand, average inj rate 7 BPM. Swabbed 188 bbls load oil in 7 days. Fraced perforations from 2962-2966, 2968-2972, w/ 30,000 gal Humble Frac and 45,000# sand, average injection rate 9.8 BPM. Swabbed and flowed 530 barrels in 87 hours. Installed rods and tubing. Pumped 42 barrels load oil, 228 hours. Well temporarily abandoned-no plug placed in hole per telephone conversation between Mr. Beville and Mr. Armstrong of 12-12-61. C-103 will be forwarded to NMCC every 6 months regarding status of well.
