DETAILS OF WORK

I plan to drill a 2900' Grayburg sand test, using cable tools all the way.
I will set 10 3/4" surface casing in anhydrite just above the salt at approximately 410', using 75 sacks.
8 5/8" will be cased around 2215' for a queen water shut off.
The 5 1/2" oil string will be set at approximately 2860' with 100 sacks.
All casing will be run and cemented using procedures approved by the U. S. Geological Survey.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
