## DETAILS OF WORK

WE PROPOSE TO DRILL THE ABOVE WELL AS FOLLOWS:

OBJECTIVE: Premier Sand (Basal Grayburg)

TOTAL DEPTH: Approximately 2960'.

METHOD OF DRILLING: Cable tools to total depth.

CASING PROGRAM: Will run approximately 400' of 8 5/8" OD casing and obtain formation shut-off. Will run approximately 2260' of 7" OD casing and mud with Aquagel. If commercial production is indicated, a production string of 5 1/2" OD casing will be run and cemented with 150 sacks. If surface water is encountered, after fracturing well, 8 5/8" casing will be pulled loose and 50 sacks cement spotted above top of salt.

DRILLING CONTRACTOR: Needham Drilling Co.

DRILLING OPERATIONS TO COMMENCE: On or about January 30, 1960.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

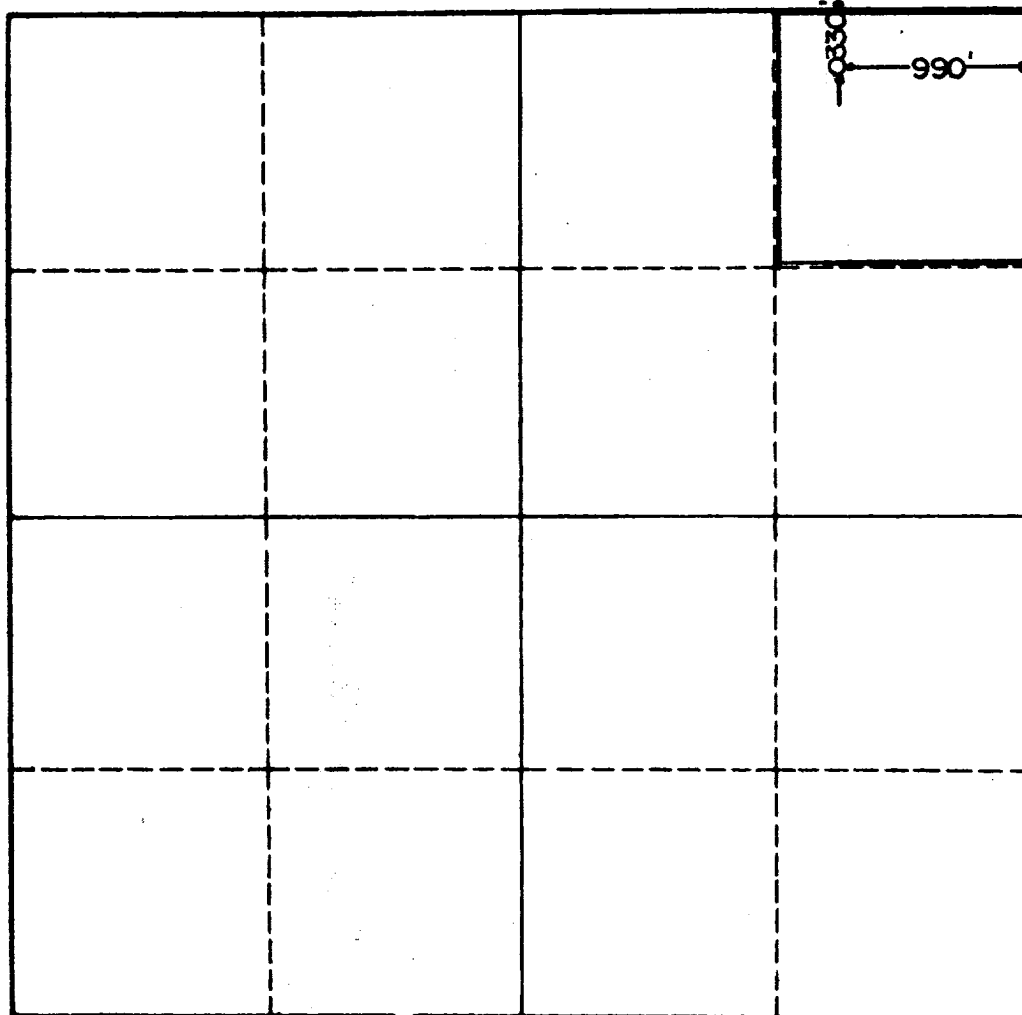
