## DETAILS OF WORK

Subsequent to our verbal conversation of this afternoon, we plan on moving 50' Northeast of the old No. 4 well and re-drilling said well to be known as No. 4-X. We plan on drilling to a depth of approximately 510' or the top of the salt and setting 7 5/8" surface pipe. Then test pipe for water shutoff. After waiting required amount of time, we will proceed to drill to total depth of approximately 3200' and complete well by setting through with 4 1/2" casing and perforating; all according to Government rules and specifications.

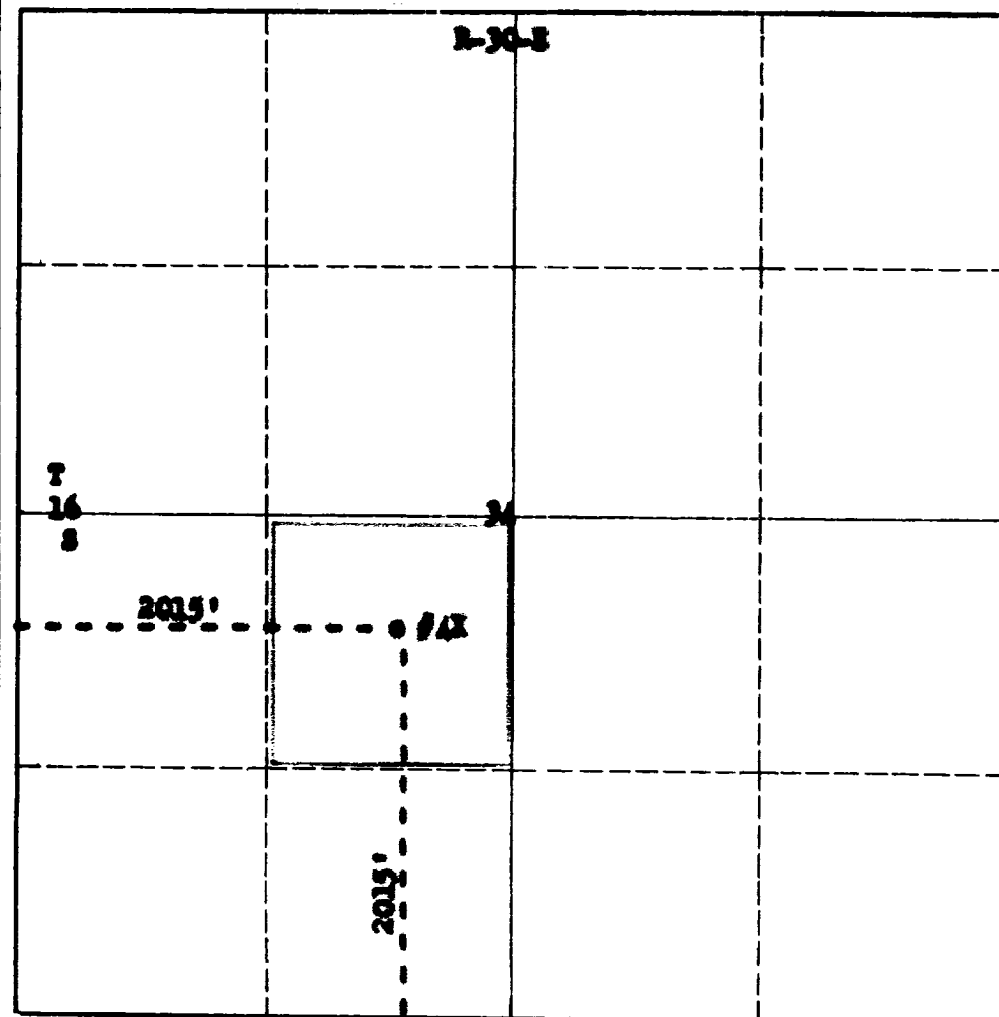
