DETAILS OF WORK

We propose to drill Shell Trigg-Federal Well No. 7 as a 3400-foot San Andres test w/rotary Tools as follows:
Drill 9 5/8" hole to 200' & cement 24#, 7 5/8" casing w/120 ex. Circulate cement.
Drill 6 3/4" hole to 3400' & cement 6.5#, 2 7/8" casing w/200 ex. on bottom and 50 ex. spotted at top of salt through 1".

Note: This slim hole completion will be similar to our Trigg-Federal 2 7/8" completion.

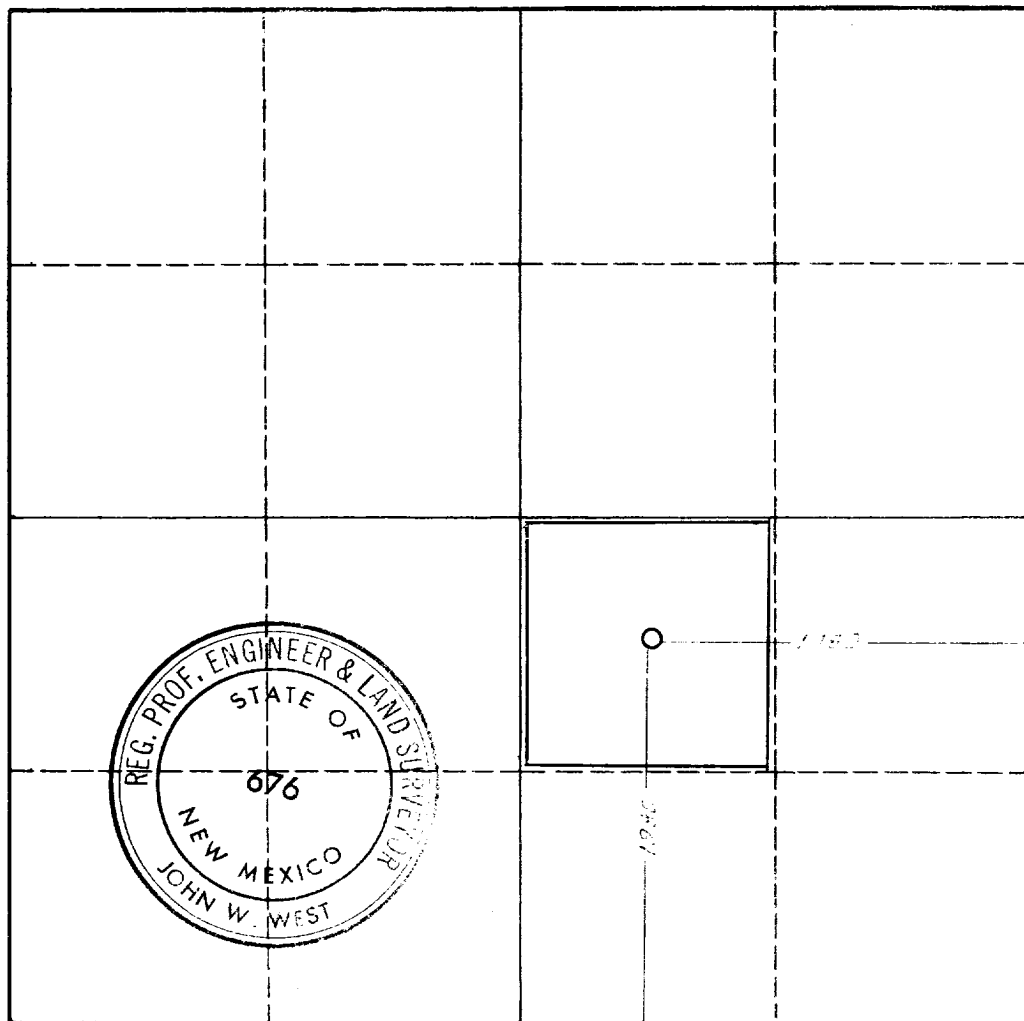
