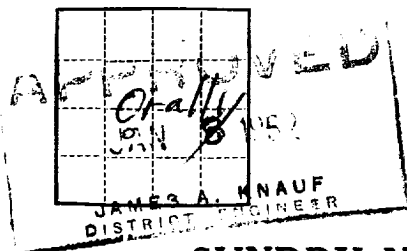

DETAILS OF WORK

We plan to drill a 3230' Grayburg Sand Test using Rotary Tools.

We plan to set 620' of 4 1/8" casing in the top of the Anhydrite with 100 sacks.

The oil string will be approximately 3230' of 4 1/2" cemented through any pay sands with 200 sacks.

All casing will be run and cemented using methods approved by the U. S. Geological Survey.

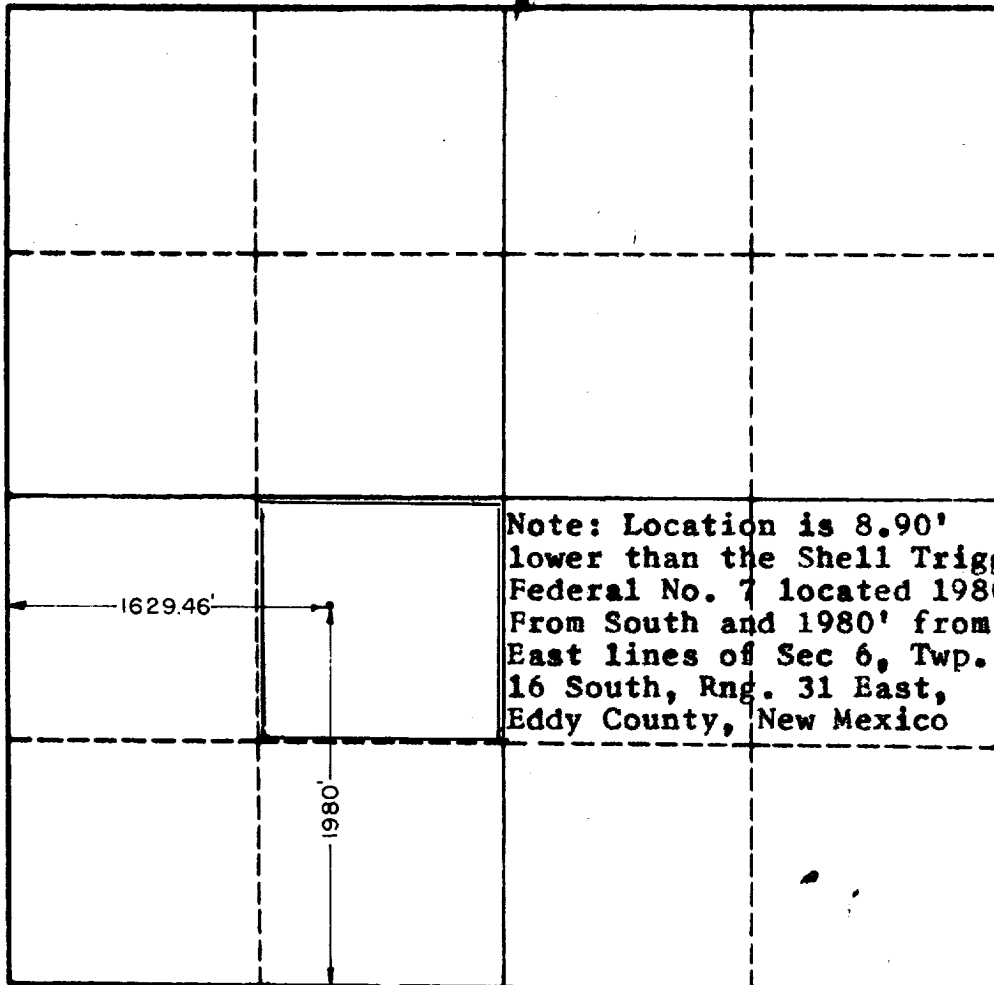
