DETAILS OF WORK

To drill to the San Andres formation at an approximate depth of 3900 feet in search of oil and gas reserves. To set approximately 400 feet of 8 5/8" 32 pound surface pipe with 50 sacks of cement and to set 5 1/2" 15.5 pound casing through production. Production string to be cemented with approximately 100 sacks of cement. In the event that water is encountered in the Queen sand, 7" casing will be run to shut off that water.
