

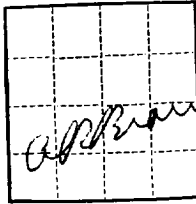

DETAILS OF WORK

U. S. GEOLOGICAL SURVEY

We propose to drill to approximately 3600 feet with rotary tools and attempt completion in the Grayburg and/or San Andres pay zones. Casing program will be as follows: 3-5/8 inch casing set at 350 feet to be cemented to surface; 5-1/2 inch J55 15.5 oil string will be set at 3600 feet and cemented with 250 sacks cement. Drilling contractor will be Vega Drilling Company of Midland, Texas.
