## DETAILS OF WORK

We propose to drill to a total depth of approximately 3600 feet with rotary tools and complete in the Grayburg and/or San Andres formation. The casing program will be as follows: 8-5/8 inch 24#, J55 surface casing to be set @ 300 feet and cemented with 200 sacks. Cement will be circulated to surface. Salt section will be isolated from fluids above & below by spotting cement plug @ 600 feet. 5-1/2 inch 15.5#, J55 casing set @ 3600 feet & cemented with 250 sacks cement.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

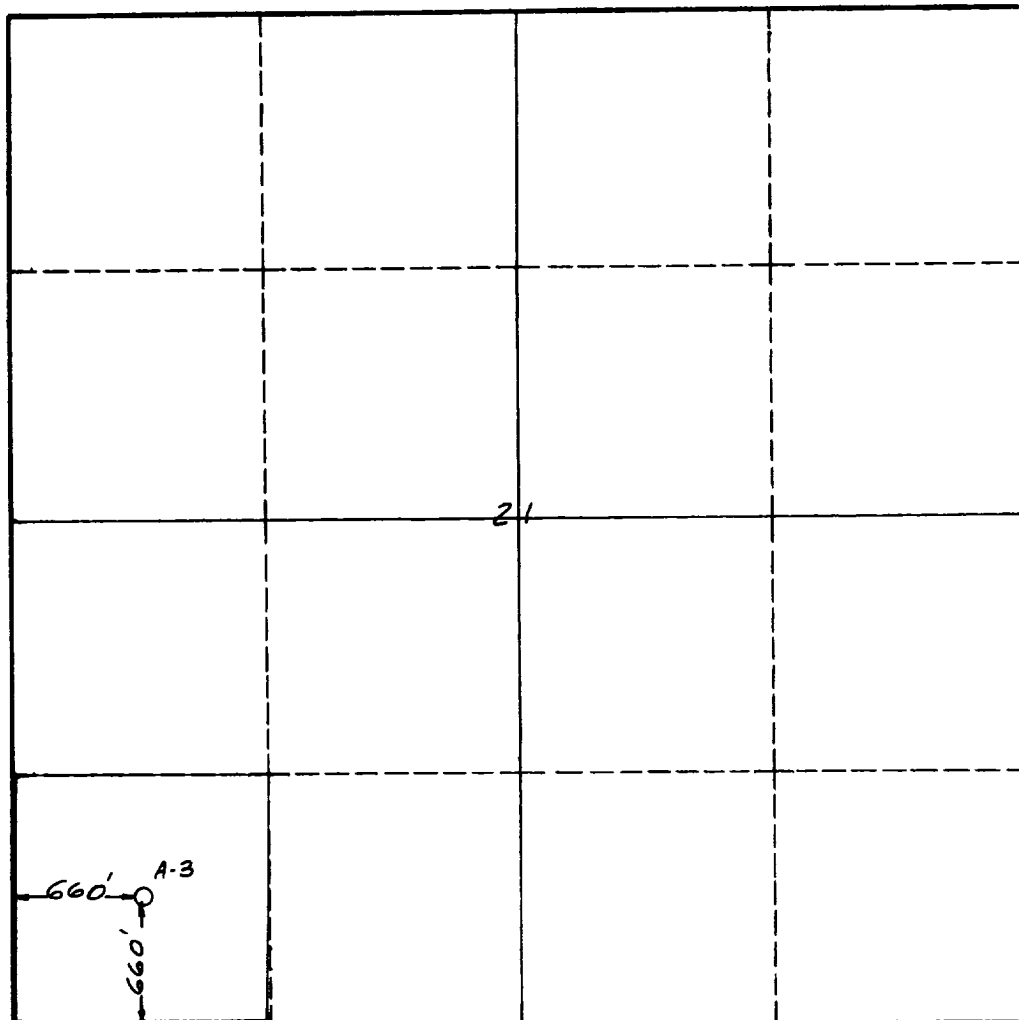

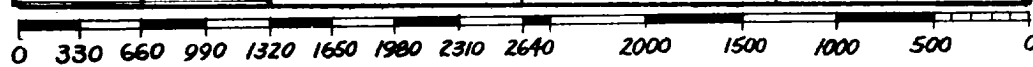
