Fracture treated Open hole section 3450-3550' with 25,000 gallons salt water and 22,000 #s 20-40 sand. Placed 500 #s Gyp Ban in this treatment. Average treating pressure was 3400 psi @ 9.6 bbl/minute down 2 1/2" tubing.

Perforated:

3089, 3090, 3126, 3127, 3128, 3129 and 3130 with .41 jet holes. Fracture treated this section with 10,000 gallons salt water and 8,000 #s 20-40 sand.

The above work was done on 9-11-67.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
