10-24-65 Tubing stuck, backed off with string shot, washed over and recovered tubing.
10-28-65 Logged to 3248. Ran bit and commenced deepening.
11-2-65 Drilled to 3340, top of Livingston Sand 3302
11-4-65 Ran tubing, rods, and pump and placed on production. Well active 11-4-65

This well has been active since the above date and is presently producing.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
