Intentions are to pull the rods and tubing, clean well out to T.D., at 3,300' and run approximately 300' of 4 1/2" O.D. 9.5# casing for liner. Liner will be cemented. Gamma Ray - Neutron and caliper logs will be run and perforations will be picked from logs. Perforations will be isolated with packers and treated via 2" tubing with sand and water for stimulation. Tubing and rods will be run and well will be placed on production as a producing well.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
