Work was commenced January 23, 1967. Pulled tubing and rods. Cleaned well out to 3,317'. Deepened well from 3,317' to 3,376' with 4 3/4" bit. Ran Gamma Ray Neutron and Caliper logs. Ran 380' of 4" O.D. FJ-40 11.34# Hydril liner and cemented liner with 150 sx class C cement. Squeeze top of liner with 50 sx Class C cement. Perforated w/2 per ft jets from 3,367' to 3,359', 3,248' to 3,240', 3,215' to 3,208', 3,203' to 3,198' total of 56 holes. Treated all perforations with a total of 37,650 gal slick water and 23,500# 20-40 sand. Ran production tubing and rods and placed well on production as a producing well.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
