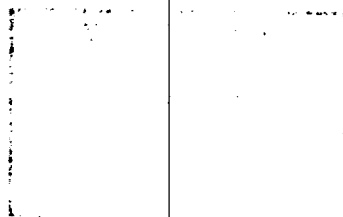
It is proposed to knock out bridge plug at 3908, circulate hole clean to 3980 & return to production.
