DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Hole was spudded and drilled to 50 feet. It was planned to set one joint 10-3/4" conductor. Cable tool contractor set one joint 8-5/8" in error and moved off, rotary tools moved in on May 17. Pulled conductor on May 21, ran and cemented 8-7/8" x 32# seamless casing at 926.21 feet. Cemented with 250 sacks cement. Top anhydrite at 880 feet.
