Well No. 1 - has been shut-in for several months. It was originally intended to convert this well to injection, but plans for waterflooding were not completed.

Wells No. 2 & 3 - Considerable workover has been performed with very small production resulting.

Under a plan now completed, these wells will be transferred to new ownership at December 31, 1974, and extensive workover and secondary recovery plans are made for all three wells.
