MTP 3000#, Min 1100#, ATP 2600# @ 5 1/2 BPM. SDP vacuum. POH w/2-3/8" tbg, unloading sub, top cone & mandril. Left in hole btm part of FBRC pkr from slips down & slips. WIH w/Model FAB-1 retainer production pkr set @ 5690'. Ran 183 jts 2-3/8" EUE tbg, tbg subs & Model H seal nipple, all internally plastic coated. Loaded csg annulus w/treated fresh water. Installed press gauge on csg-tbg annulus. Commenced gas injection on 6/15/74. Final Report.
