I propose to plug and abandon as follows:

1. Place a C.I. bridge plug at 3450' and cap with 35' of cement to seal off perforations 3474-3689'.
2. Tops: Queen 2842, BS 1792, TS 804.
3. Will attempt to wash over the 5 1/2" csg, or shoot with prime cord the two staged cemented interval @ 525'. If successful will pull free pipe and place a 100' cement plug & stub. If not successful will back off free pipe above the two-stage cement top and place a 100' cement plug.
4. Place a 20' cement plug in surface casing 20'-0.
5. Place heavy sand between all plugs.
6. Set regulation marker, clear, clean and level location & notify for inspection.
6. The above work will commence August 21, 1974.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
