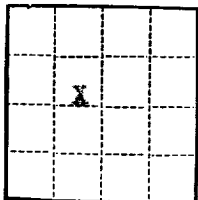

DETAILS OF WORK

(State names of and expected depths to objective sands; show sizes, weights, and lengths of proposed casings; indicate mudding, cementing points, and all other important proposed work)

We propose to drill a well at the above location to test the Yaso formation at approximately 3400 feet.

We expect to run casing as follows:

10 3/4" at approximately 150 feet and 8 5/8" at approximately 450 feet.

If we encounter further water we will run 7" to shut off same.

If oil or gas in commercial quantities is obtained we will pull the 10 3/4" and 7" and cement the 8 5/8" to your satisfaction and run a production string of either 4 1/2" or 5 1/2" and cement with 100 sacks or enough to cement above the red sand.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

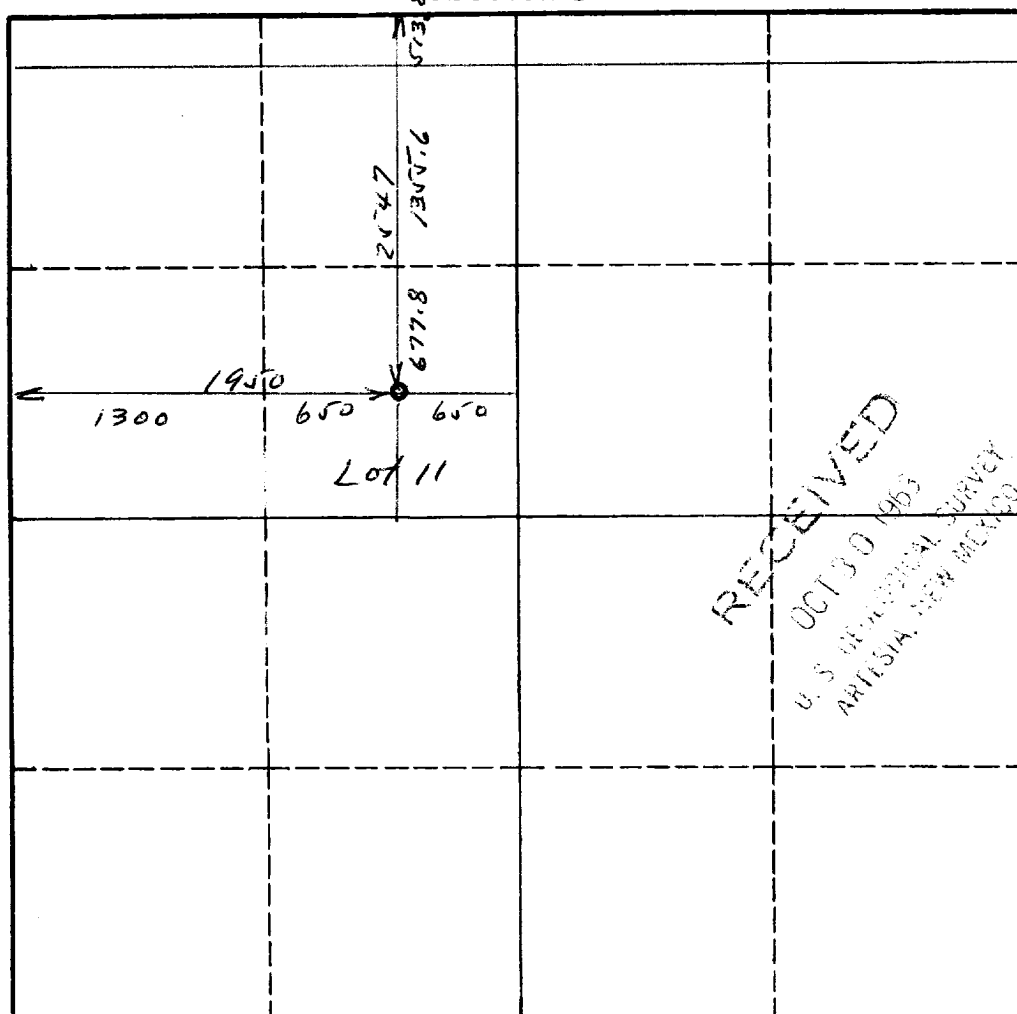

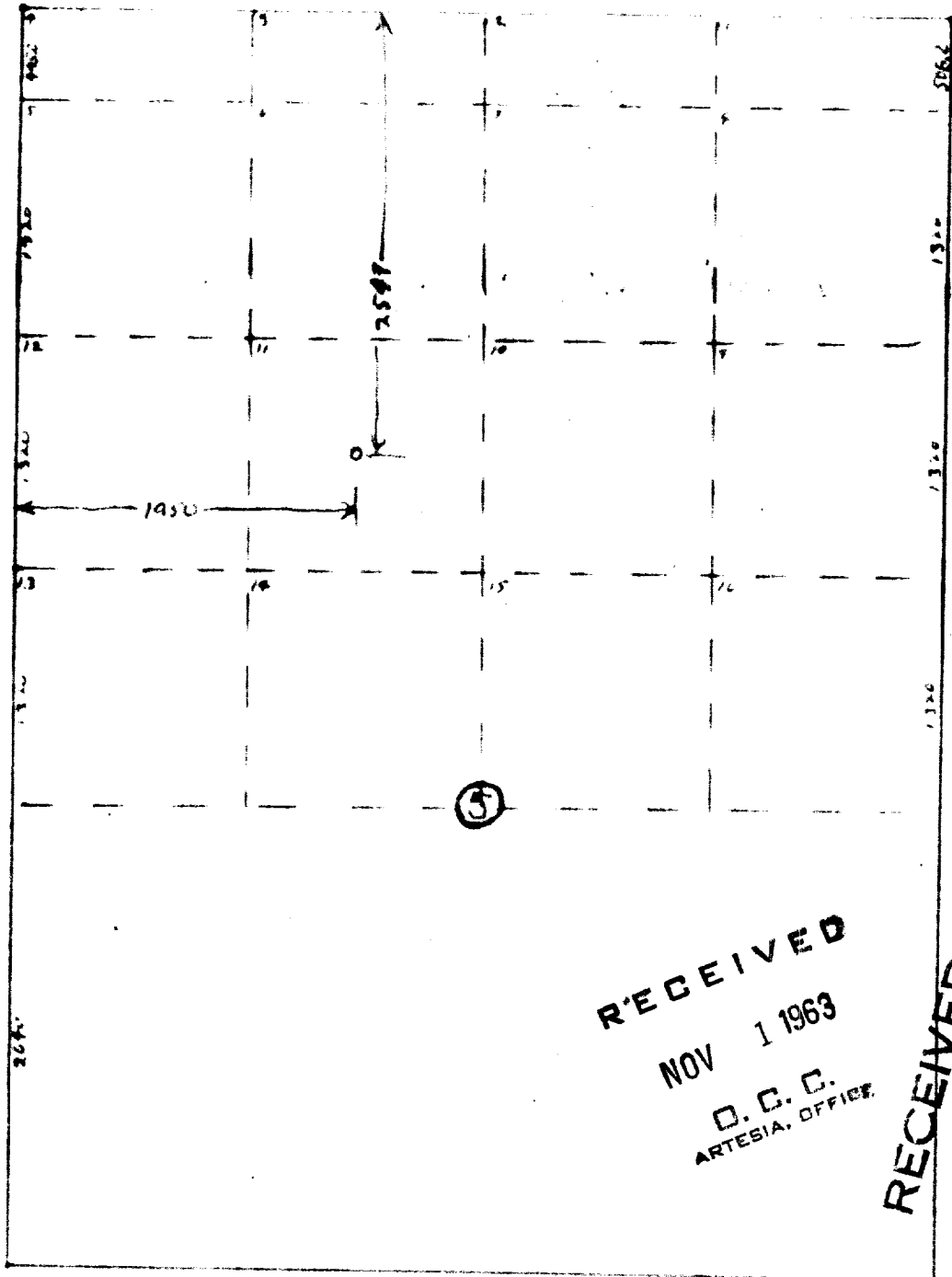
