Pursuant to telephone approval Messers Shock to Neck 11-12-64, the following remedial work is proposed in order to increase productivity:

Isolate present perforations by temporary liner, perforate intervals 1883, 1912, 1921, 1940, 1987, 2040, 2082, 2106, 2116, and 2127 with 1 jet shot each interval. Acidize with 2000 gallons and treat with 65,000 gal gel water, 30,000 sand and other agents.

Swab in, evaluate, and restore to production.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations.
