10-11-2002 - Moved in and rigged up pulling unit and plugging equipment. Rigged up rod equipment. POOH with rods. Rigged down rod equipment. Shut well in for night.

10-12-14-2002 - Nippled down wellhead and nipped up BOP. Rigged up tubing equipment and floor. POOH with tubing. Rigged up wireline. RIH with wireline set CIBP and set CIBP at 1300'. POOH. RIH and capped CIBP with 35' of cement. POOH. Rigged down wireline. RIH open ended to 1257'. Circulated hole with plugging mud. Pulled up to 1196'. Spotted 25 sacks Class C Neat cement from 1196-950'. POOH. WOC 4 hours. RIH with tubing and tagged cement at 983'. POOH. Shut well in for night.

10-15-2002 - Rigged up wireline. RIH and perforated 5-1/2" casing at 768'. POOH and rigged down wireline. RIH with packer and tubing and set packer at 488'. Squeezed with 25 sacks Class C Neat cement from 768-668'. WOC 4 hours. Rigged up wireline. RIH and tagged cement at 657'. POOH and rigged down wireline. Released packer. POOH with tubing and packer. Rigged up wireline. RIH and perforated casing at 246'. POOH and rigged down wireline. Rigged down tubing equipment. Nippled down BOP and wellhead. Installed 5-1/2" swedge. Circulated 30 sacks Class C Neat cement down 5-1/2" casing and up through 7" casing.
