- 11-13 Set 38' of 20" conductor pipe. Spudded well 11-13-71. Drilled 17-1/2" hole to 367' and ran 9 jts 12-3/4" 34# EW csg, set @ 367'. Cemented w/200 sx Class "C" 2% CaCl and 1/4# cellofane + 200 sx Class "c" w/2% CaCl. Circ approx 100 sx. WOC 18 hrs. Tested csg to 900 psi for 30 mins, held ok.
- 11-17 11" hole. Ran 46 jts 8-5/8" 24# K-55 csg. Set @ 1446'. Cemented w/450 sx Class "C" 2% CaCl, 4% gel and 1/4# cellofane/sk + 200 sx Class "C" w/2% CaCl. Circ est 300 sx to surface. WOC 18 hrs, tested csg to 900 psi for 30 mins, held ok. Tested outside 8-5/8" csg to 400 psi for 1/4 hr, held ok.
