Drilled 25" hole to 41' with rathole equipment and set 36' of 20" conductor pipe and cemented to surface December 12, 1973.

Capitan Drilling Company rigged up and spudded at 3:00 p.m. December 16, 1973. Drilled 12 1/4" hole to 1772', ran 8 5/8", 24#, K-55 casing set at 1770' K. B. Cemented with 812 sacks lite wate cement plus 200 sacks Class "H" w/2% CaCl. Plug down at 5:15 p.m. December 24, 1973. Shut down for WOC and holiday. Tested casing to 1000 psi, no pressure loss. Resume drilling December 27, 1973.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
