TD 258' - Ran 6 jts of 10-3/4" 32#, J-55 casing (245') set at 255' and cemented w/125 sx Class C 4% CaCl. PD 7:10 PM 5-8-74. Cement circulated. WOC 12 hrs. cut off landing jt, drilled plug, reduced hole to 9 1/2" and resumed drilling.

TD 1196' - Ran 27 jts of 7" 23 & 26#, J-55 casing (1153') set at 1165'KB w/centralizers at 1042 & 630', baskets at 676 & 584'. 1-Guide shoe. Washed thru bridge at 440-500', ran free to 1165'. Pumped 60 sx Incor Mix, shoe plugged. Rigged up Vann Tool Co. and perf. w/2-0.45" jets at 1164', cmtd w/290 sx Incor Mix (6% Gilsonite & 0.6% flocele) 2% CaCl + 150 sx Class C Neat 2% CaCl. PD 12:30 PM 5-10-74. No returns. WOC 6 hrs, ran Temp. Survey. Top of cmt at 780'. Ran 1" tbg and washed 360 to 496'. Spotted 100 sx Class C 4% CaCl. PD 10 PM 5-10-74. WOC 4 1/2 hrs. Firm cmt at 462'. Spotted 100 sx Class C 4% CaCl. PD 4:45 AM 5-11-74. WOC 5 hrs. Tagged cmt at 383'. Spotted 100 sx. PD 9:00 AM 5-11-74. WOC 4 1/2 hrs, tagged cement at 280'. Spotted 130 sx Class C 4% CaCl. Cement circulated. JC 1:30 PM 5-11-74. WOC 29 hrs, cut off 10-3/4" & tacked 7" to 10-3/4". Backed off landing jt and NU, tested BOP's w/1000#. OK.

Drilled plug tstd csg 500#, reduced hole to 6 1/2" & resumed drilling.
