5-31-02- TIH w/ tubing open ended to 6250'. Tested casing to 500 psi. Displaced hole w/ 2% KCL w/ 1 GPT corrosion inhibitor. Tested & chart 500 psi for 30 minutes. Laid down tubing. Cap well; top out w/ KCL. RD. Test witnessed by Paul Shultz. Test chart attached. Well is SIT/A.

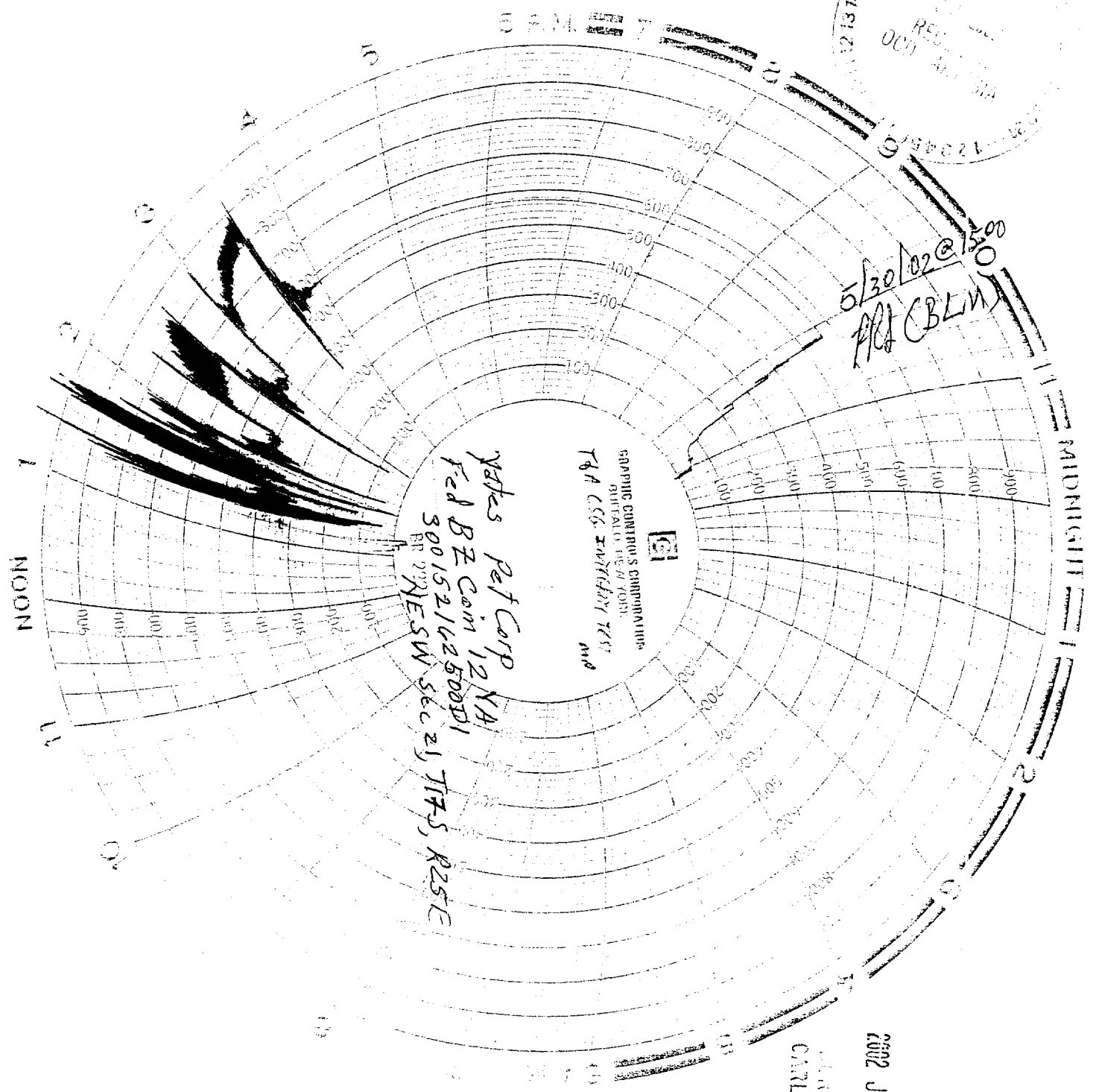
