3. Set 35 sx. cement plug 6420'-6320'
4. Set 35 sx. cement plug 4400'-4300'
5. Set 35 sx. cement plug 2300'-2200'
6. Run 4 1/2", 10.5#, J-55, S.T. & C. casing and set @ approximately 2150' RKB.
