Cemented by Denton w/350 sacks of Incor Mix 2% CaCl followed w/250 sacks of Class C 2% CaCl. PD 8:00 AM 5-16-76. Cement did not circulate. WOC 6 hours, ran Temperature Survey, found top of cement at 800' at 2:00 PM 5-16-76. Ran 1" to 357', spotted 75 sacks of Class C 4% CaCl. PD 5:30 PM 5-16-76. WOC 2½ hours. Ran 1" to 341' and spotted 75 sacks of Class C 4% CaCl. PD 8:15 PM 5-16-76. WOC 2½ hours. Ran 1" and tagged cement at 341', spotted 50 sacks of Class C 4% CaCl. Pulled 84' of 1" to 256' and spotted 50 sacks of Class C 4% CaCl. PD 11:30 PM 5-16-76. WOC 2 hours, tagged top of cement at 325', spotted 75 sacks of Class C 4% CaCl. PD 2:05 AM 5-17-76. WOC 2 hours tagged top of cement at 325', spotted 75 sacks of Class C 4% CaCl. PD 4:30 AM 5-17-76. WOC 2 hours, spotted 100 sacks of Class C 4% CaCl. PD 8:30 AM 5-17-76. followed w/3½ yards of Ready-Mix cement at 8:45 AM 5-17-76. Cement holding. (1100 sacks). WOC 18 hrs, NU, instld BOP's tstd to 1000#.OK.
