TD 1485'. Ran 10 joints of 4½" 10.5# H-55 (411') and 27 joints of 5½" 15.5# J-55 (1061') (37 joints 1482') set at 1485'. 1-Guide shoe and 5 centralizers at 1431, 1390, 1349, 1307 and 1266'. Cemented w/150 sacks of Class "C". Cement circulated. PD 5:30 PM 6-1-76. WOC and tested to 1000#. OK.

TD 1485'. Perforated 1334-1478' w/25 .45" holes as follows: 1st Stage: 1337, 50, 61, 65, 69, 73, 77, 83½, 91, 99, 1475 (11 shots). Acidized w/4000 gallons of 15% regular acid. 2nd Stage: - 1334, 53, 59, 63, 67, 71, 75, 80, 86, 93, 1410, 72½, 78 (13 shots). Treated all perforations w/100000 gallons of treated water and 130000# 20-40 sand and ball sealers.
