This test was spudded on September 11, 1976 and drilled to 261 feet, reached September 10, 1976. The bailer was run to clean the hole and became stuck. While trying to recover the hole caved and after two days of fishing with no success the hole was abandoned with a 21 foot bailer left between 240 and 261 feet. The hole was filled with red-mix cement on September 13, 1976.
