Dear Rand,

January 4, 1995 we began a dialogue with Mr. Harvey Yates Jr. about plugging the above captioned wells.

To give you a brief history, these wells were all drilled to approximately 300' and surface casing set and cemented. The wells were then drilled to TD and a drill stem was ran. There has not been any production casing run on these wells. This company then moved off of the wells leaving them in this condition and began drilling the next well.

After several letters and telephone calls, the Rox #3 and Sardine #1 have been plugged. The Sallie #2 was cleaned out to 1900' so that it could be plugged, then they decided to take another look at the logs and maybe run pipe, which is alright, but it has been almost three months sitting idle because his contractor refuses to work any longer without payment.

I wrote Mr. Yates in July 1995 in regard to another well in Otero County which also needs to be plugged and had no response at all. I then called him and told him the well would need to be properly plugged. This well is the Virden #1.

On February 12, 1996 I received a call from Mr. Don Bell, a VP for Cibola Energy Corp. Mr. Bell told me they did not have the money to plug these wells and he asked me for a little time because they were trying to go public with the company to raise some funds. I told Mr. Bell to send a letter to Tim Gum stating what he had just told me. To date there has been no word at all. March 27, 1996 Rand Carroll, Legal Bureau

The Virden #1 and the Cowboy #1 are the only wells that have production casing set to TD.

Tim Gum has instructed me to ask for a hearing to be scheduled to show cause why these wells should not be plugged to protect fresh waters of the State of New Mexico, the environment and correlative rights in the area.
