Will drill out of the 8 5/8" casing with 7 7/8" bit to approximately 2700'. Will then run 2700' of 4 1/2", 10.5# casing and set with 650' Sxs. of cement, circulating to surface. Logging and perforating will be done on drilling samples and gamma-ray neutron log.

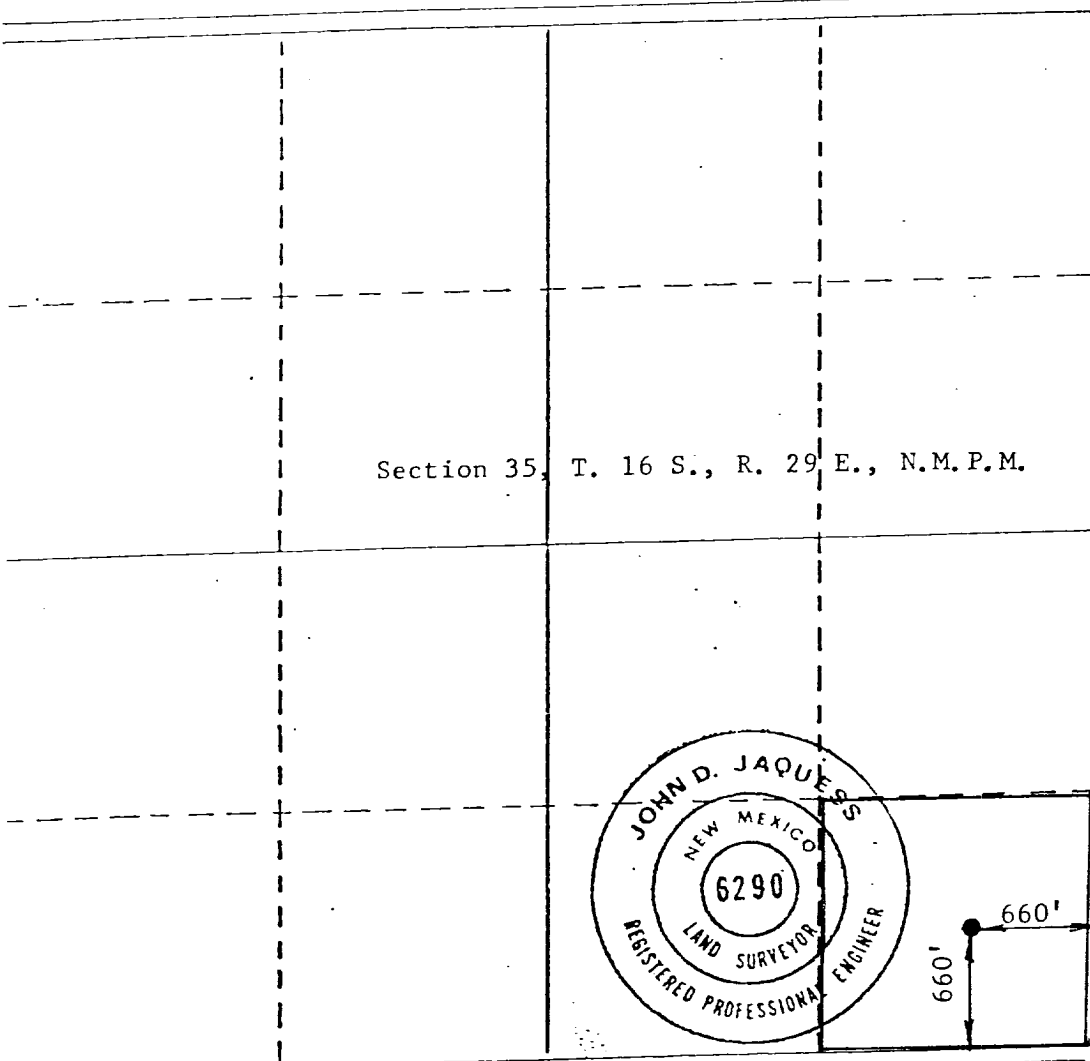
