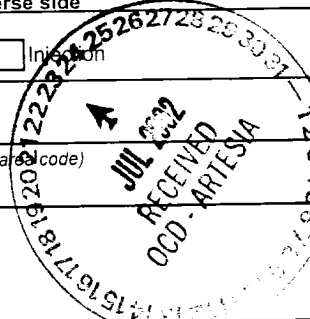

NOTIFY BLM IN CARLSBAD 24 HOURS BEFORE STARTING PLUGGING OPERATIONS.

1. RU WL company. Make gauge ring run to 1200'. Set CIBP @ 1200'; dump 35' cement on plug.
2. MIRU WSU. ND wellhead; RU cementers. TIH w/ tubing & tag cement on CIBP @ 1165'. Circulate hole w/ cement.
3. Rig down, clean location & install regulation marker.

If the wellbore meets certain requirements such as casing integrity & capacity, it is proposed to place several cubic feet of spent gas treating catalyst in the wellbore & between the cement plugs. Special marking will be placed on the dry hole marker to identify this procedure.
