Rigged up wireline. RIH with CIBP and set CIBP at 1130'. POOH and rigged down wireline. RIH with tubing to 1130'. Rigged up cement equipment. Circulated 85 sacks Class C Neat cement from 1130' to surface. POOH and laid down tubing. Rigged down tubing equipment. Nippled down BOP and wellhead. Topped hole off with cement. Rigged down pulling unit and plugging equipment. Installed regulation abandonment marker. PLUGGED AND ABANDONED - FINAL REPORT. Plugging completed 9-4-2002.
