Mewbourne Oil Company hereby requests authorization for "off lease" gas measurement on the above mentioned well as the location of the gas purchasers sales point will be off lease. In doing this, Mewbourne also requests surface usage to run a gas salesline above ground along the existing roadway into the well. The well is very marginal and will only be selling 10-15 mcf/day. The salesline will consist of Phillips SDR-11 polypipe rated at 165 psi. Maximum operating pressure will be 40 psi. The salesline will be 5200 feet in length and along archaeologically cleared right-of-way.

See attached plat for location of salesline and location of measurement station. The meter station will be located on the Fulton Enterprises Meridian Federal #1 in Sec. 25-T16S-R28E.

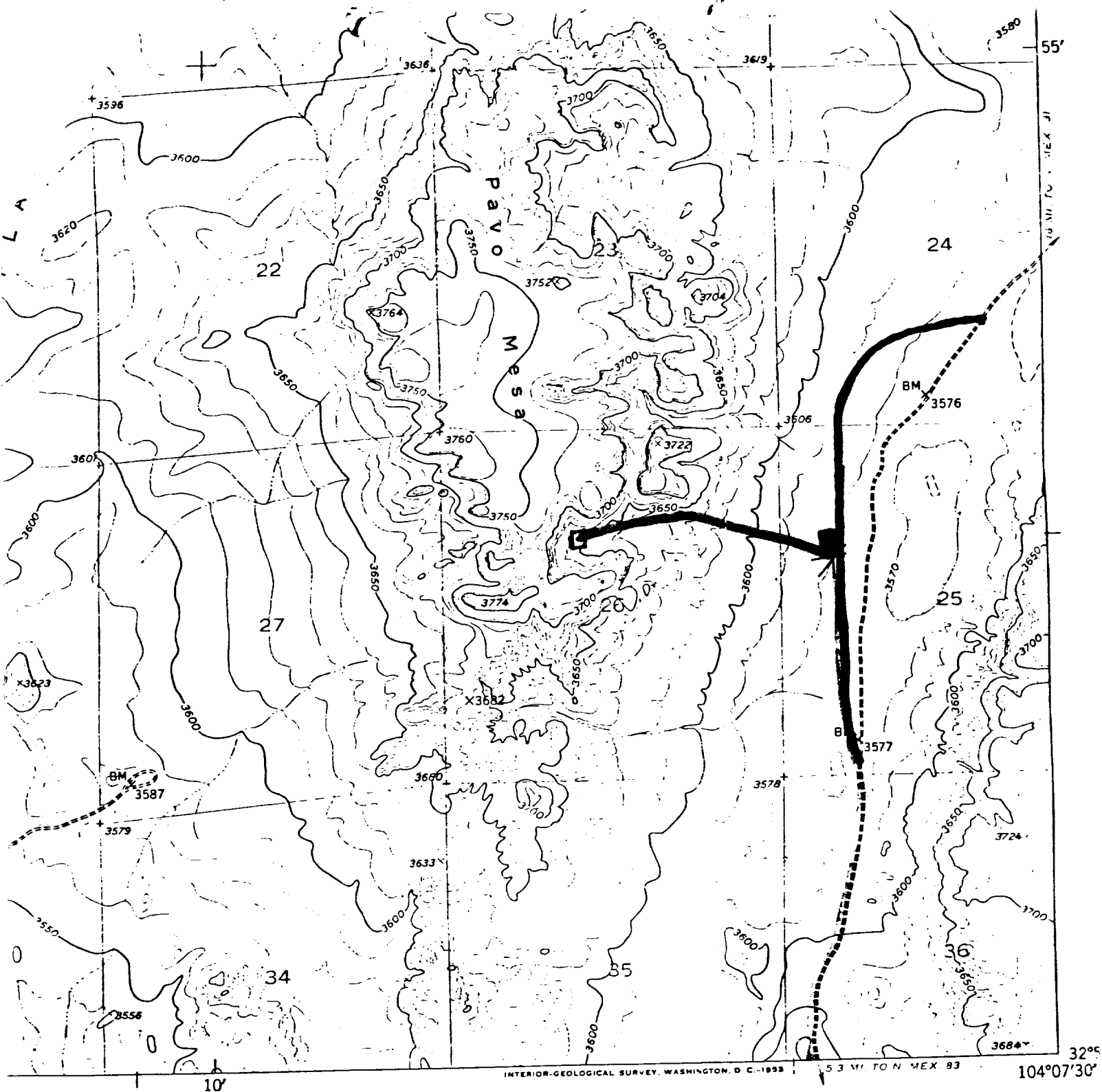
